If the term is over 1 year, interest must be credited at least annually.</li> <li>Accrual of interest begins on the business day you deposit cash or noncash items (e.g., checks).</li> <li>The daily balance method is used to calculate the interest on your account. This method applies a daily periodic rate (annual interest rate divided by 365, or 366 in a leap year) to the principal in the account each day.</li> <li>If you close your account before interest is credited, you will receive the accrued interest.</li> </ul>					
	<ul> <li>Interest rate is fixed for the term until the maturity date.</li> <li>The minimum balance of \$1,000.00 is required to obtain the stated Annual Percentage Yield (APY) and maintain the account.</li> <li>The APY assumes that interest remains on deposit until maturity. Early Withdrawal Penalty	<ul> <li>An early withdrawal penalty may be imposed for withdrawals made prior to maturity.</li> <li>If your account has a term of six (6) months or less, the early withdrawal penalty will be the amount equal to 30 days simple interest.</li> <li>If your account has a term greater than six (6) months and less than eighteen (18) months, the early withdrawal penalty will be the amount equal to 60 days simple interest.</li> <li>If your account has a term of eighteen (18) months or longer, the early withdrawal penalty will be the amount equal to 90 days simple interest.</li> </ul>					
Renewal Policy	<ul> <li>Automatic Renewal:</li> <li>This account will automatically renew as Hope Preferred Certificate of Deposit on the maturity date. If you choose not to renew this account, simply withdraw the funds at maturity or provide written notice within the grace period (ten calendar days). Bank of Hope may also choose not to renew the account by mailing a written notice at least 30 days prior to maturity. If account is not renewed, interest will not accrue after the final maturity.</li> </ul>
